purposes for 4 days. The operator (not Burlington) has not forwarded correct documention to authority and Burlington had not notified			
Authority that it was being used on site. All spraybars and covers were noted during inspection although machinery was not in operation at time of inspection. Issues surrounding complaints received at Elterwater Quarry specific relate to dust, further investigation has			
identified spraybar's not being used and in some cases defective. END.
