## Habitats Regulations Assessment: November 2017 Update

## 1. Background

- 1.1. Barrow Borough Council produced the Pre-Submission Draft of its emerging Local Plan in March 2017.
- 1.2. A full screening and appropriate assessment was carried out at pre-submission stage and the results were contained within the Habitats Regulations Assessment March 2017 document.
- 1.3. The Council proposes a number of changes to the Pre-submission Draft in light of new evidence and consultation responses. These changes will be incorporated into the emerging plan to form the Submission Draft.
- 1.4. Barrow Borough Council intends to submit the Local Plan Submission Draft to the Planning Inspectorate in January 2018 following a round of consultation.
- 1.5. This HRA document screens the proposed modifications in order to assess whether they would alter any of the conclusions previously reached in the March HRA, or introduce any new impacts or effects.
- 1.6. Changes to wording in the supporting text in the Plan, or in correcting typographical errors, are not considered to present any implications for the Local Plan as a whole to impact on European sites. Only amendments to policies (including any draft allocation site boundaries) have therefore been assessed at this stage.
- 1.7. A full list of modifications can be found in the Barrow Borough Local Plan Submission Draft Schedule of Proposed Major Modifications document, November 2017.
- 1.8. Changes which relate to policies or draft allocated sites are assessed below in Table 1.

## 2. Summary of Results

2.1 Taking into account the March 2017 HRA and the results in Table 1 below, the policies and sites within the Submission Draft of the Local Plan will not result in any likely significant effects on any European Sites.

The policy continues to fall into the C1 category as it is one which steers a quantum or type of development that could have a direct adverse effect upon the European site, although the effect would be dependent upon how the policy is implemented in the future e.g. location and scale of development brought forward.
