- 1.1 The Barrow Borough Local Plan 2016-2031 (the new Local Plan) was adopted on 4th June 2019 and replaces the Saved Local Plan. Therefore, all policies of the Saved Local Plan have been cancelled. The Saved Local Plan consisted of:
 - Barrow-in-Furness Borough Council Local Plan Review 1996-2006; and
 - The Housing Chapter Alteration 2006.
- 1.2 The new Local Plan also supersedes in whole or in part some policies of the Barrow Port Area Action Plan 2010.
- 1.3 Note that the following policies have previously been cancelled and have therefore not been included in the tables below:
 - Policy G1 and policies B1-B25 of the Local Plan Review were cancelled from 2nd June 2006;
 - Policies A2, D14, F17 and G11 of the Local Plan Review were cancelled from 28th September 2007;
 - Policy B2 of the Housing Chapter Alteration 2006 was cancelled from 2nd June 2009;
 - Policy A15 of the Local Plan Review was cancelled from 12th July 2010.
